Debt Issuance Plan | Debt Service Payment Estimates

Summary

Below is a brief summary of the financing plan components:

- Refund (restructuring) Debt
 - o current outstanding debt of \$840,000 will be repaid in FY2025
 - o restructuring will shorten the repayment schedule by around one year
 - o lower interest rates and shorter repayment is estimated to result in taxpayer savings of approximately \$25,000 in aggregate
- Referendum (New) Debt
 - o new principal of \$5,800,000 to fund new project
 - o will extend the repayment schedule on the District's overall debt by 15 years to FY2040
 - o This type of debt issuance structure, commonly call a wrap-around structure, is a very common financing method employed by Iowa School District due to the existence of levy limitations.

Estimated Repayment Schedule

Below is the current estimated debt repayment schedule:

- Assumed interest rates are that are approximately 0.50% more conservative than today's rates (approximately 1.81% on the refunding, approximately 2.97% on the referendum)
- The District can implement the \$2.86 levy in FY2021 without an increase in the District's overall property tax levy rate (see "Memo Regarding Financing Plan" for more details)
